
## County Fair Exhibit Goes to Church:

*"Touching the head through the heart", Pauline Warren*

A local pastor visited our pro-life exhibit at the Clark County Fair this year and saw two members of his church, Red and Pauline Warren, working there. He invited them to make a 15 minute Right to Life presentation to church members. They began their 15 minute presentation asking those present to join together in praying Psalm 139. In Pauline's words: "To God, our Father, each one of us is special, a precious human being, made in His image from conception to the end of life. We are valued and unique."


Then she introduced Baby Steps: "This short video will show us the inside of the womb, the development of which all of us went through---even Jesus went through...in Mary's womb."

"So what do Red and I do at the fair at the Right-To-Life booth? We talk to people, little people and big people, about their development in their mother's womb and how special they are...but mostly we encourage them to hold these dolls, each one a replica of a baby in the mother's womb." At this



point Red holds up one of the dolls. Pauline continues: "Nothing quite strikes the heart as holding one of these baby dolls, not just for children but for adults as well. Pregnant mommas show their children how big the baby is in her womb. It is quite moving!"
