thousands in our community. This is accomplished through bill-boards, online resources, and local pregnancy resource packets. Each packet includes a local pregnancy resource card, an abortion pill reversal card, a 40 Days for Life card and a "This is not your only choice" street booklet. Each of these cards are folded, nested together, and placed in a Ziploc bag.

Once a year, new packets are assembled to replenish the supply (as they are given out during 40 Days for Life at the local PP abortion center and during the Clark County Fair at the CCRTL exhibit). A number of young adults at my church (Hockinson Apostolic Lutheran) have assisted with this task in the last couple years, so Gerry asked if we would be willing to help again. After a recent Bible study, we assembled the latest batch of packets. As I was delegating tasks and setting supplies out, I soon noticed the new packets were being assembled in a different order than we've done in the past. My instructions had not been clear, so the new people who were helping had begun to assemble them in the order that made sense to them. I told them the packets were in the wrong order, however, they soon convinced me that the way they were assembling the packets (with the "This is not your only choice" booklet on the outside), conveyed our message in a more visually appealing way than our former method. As a result, we decided to continue assembling the rest of the packets in this manner. Perhaps the 'mistake' was a blessing in disguise! Whatever the case. may God help us to stand up for the value and purpose of every human "Listen. A message from our Vice President, Dorothy Gill

Language, arguably the most basic and necessary tool of a society, was weaponized long ago in the attack on human life, infamously resulting in the popular use of the word choice to frame the abortion battle. Care and compassion suffered similar fates, twisted and wrapped around their complete opposite meanings to frame the assisted suicide/euthanasia battle. Exploiting a free people's fear of losing any rights, the death mongers effectively crafted their slogans. Defending rights = good, denying rights = bad. Yes, we all agree on that. But only if the right is truly endowed on the subject. A mother has no inalienable right to kill her child. A patient has no inalienable right to be killed by his doctor. Laws that allow direct killing of the vulnerable humans at the beginning and the end of life are as unjust as laws allowing slavery. Reclaiming the language that frames this debate is essential. We are the defenders, working to restore legal protection for life and fighting the laws that deny these rights. Be very vigilant in your speech, accurately contrasting your goals to the enemy's goals. One simple example of this is the CCRTL banner that reads "Washington State Law denies protection for babies' lives before birth".
